INSTRUCTIONS FOR FILING APPLICATION FOR EXEMPTION REAL ESTATE & BUSINESS PERSONAL PROPERTY TAXES

The Louisiana Constitution Article 7, Section 21(B) has four (4) requirements for a non-profit **exemption** from ad valorem taxation:

- a. The property owner must be a **non-profit** corporation organized and operated exclusively for religious, dedicated places of burial, charitable, health, welfare, fraternal or educational purposes;
- b. No part of the net earnings may benefit any private shareholder or member;
- c. The **non-profit** corporation must have been declared **exempt** from federal or state income taxation; and
- d. The property cannot be owned, operated, leased, or used for *commercial purposes* unrelated to the exempt purposes of the corporation or association.
- 2. There is no automatic tax exemption. You must file an application to qualify for tax exempt status.
- 3. Tax exemptions that have been approved will remain in place unless we are notified of a transfer of the property by the Parish Conveyance Office.
- 4. When filing an application, please include a copy of your 501(c)(3) IRS determination letter. Exemption from federal and state income taxes does not automatically constitute exemption from real estate/business personal property taxes nor does non-profit status. You must meet the requirements of Louisiana law as required for exemptions.
- 5. An application must be provided for <u>each</u> property, including vacant lots, for which an exemption is requested.
- 6. If you receive a tax bill and have an application pending, you should pay the bill to avoid any penalties should your application be denied.
- 7. If your application is approved, the notification letter will specify what **(tax) year** the exempt status will become effective.
- 8. If there is a change in the use of ownership of the property, you are required to file a new application.

THE FOLLOWING INFORMATION SHOULD BE SUBMITTED WITH YOUR APPLICATION:

- (a) IRS 501(c)(3) Determination Letter;
- (b) The latest IRS Forms 990 and 990-T filed with the IRS;
- (c) Articles of Incorporation;
- (d) Louisiana Non-Profit Certification from Secretary of State; and

Any publications, pamphlets, flyers, newsletters or electronic media, etc., that describes the activities of your organization.
